3. Declarations of Conflict of Interest:

5. Matters Arising:

PB – Clarity on what an 'Investment Zone' is?

<u>MM</u> – Section 106 agreed in July – Every council in the country can apply to be part of an investment zone. Application was submitted on Friday for the airport, UKBIC, Jaguar Landrover sites to become an investment zone.

<u>TW</u> – Becoming an investment zone opens opportunities to get funding.

6. Airport Update:

<u>AH</u> - Staff – Paul Pendleton-Brown (MATS) has left the company and Steve Lindon has been promoted to Senior Aerodrome Flight Information Service Officer (SAFISO). Ground Crew Manager has left and there is a vacancy to be filled within the department.

Movements are up on previous year which currently stands at (as of 31/10/2022) 26,834 (1,455 more than 2021 with 2 months still to go).

Hangars are occupied and getting enquiries on a regular basis.

PB - Could there be an update on the airports financial status given?

<u>RW</u> – How much longer are the based operators going to be subjected to the uncertainty of closure and how likely is it that the giga-factory will go ahead and If the giga-factory does not proceed will the lease holders continue to support the airport or is a change of use more likely to take place?
